This booklet contains the documentation regarding the certification for exclusive alimentary use of the Decojet REVOLUTION, multifunction printer commercialized by Moddecor Italiana S.r.l. This printer is equipped with tanks containing alimentary inks, that is hydro alcoholic solutions of alimentary additives with an acid pH factor.

Some of the printer parts may come in direct contact with the alimentary print supports and the printer heads with the inks. For this reason we have carefully evaluated the suitability of the machine parts and the printer heads that may come into direct contact with "foodstuffs" according to the European laws that govern materials destined to come into contact with alimentary substances.

This booklet contains the documentation necessary to be supplied in case of verification by the Sanitary Authorities.
